IMPORTANT NOTE:

- 1) Deficient Documents (Marked with red in the list) must be submitted as soon as possible upto 04 JULY 2015. Otherwise admit card will not be issued and candidate will not allowed to appear in entrance examination on 14 JULY 2015
- 2) Candidates without any deficiency, who won't receive admit card due to postal delay, they can directly collect the admit card from the institute after 04 JULY 2015. The candidate have to come with 02 recent passport size photograph.
- 3) Eligible Candidates having deficiency can collect admit card from the institute after 04 JULY 2015, subjected to clearing all the deficiencies.
- 4) For availing the Reservation/Category facility (ST/SC/OBC), the candidate must submit Caste Certificate issued by Madhya Pradesh Government upto 04 JULY 2015, otherwise they will be treated as "General Category" Candidates.
