- 2. Quotation /Tender will be opened on the same date at 16:00 hrs. The quotation received after due date will not be entertained. All bidders are requested to submit their bids in 2 parts as under:
 - a) Technical bid consisting of all technical details along with commercial terms and condition like
 - i) Registration certificate of the firm.
 - ii) PAN No with photocopy of PAN Card.
 - iii) Technical details / specifications / catalogs of the items.
 - iv) Photocopy of TIN No of the firm
 - v) Photocopy of Income Tax/Sale Tax clearance certificates
 - b) Financial bid indicating item wise price of the items mentioned in the technical bid like:-

 - 6. A Technical Committee / BOD will inspect the items to verify the technical specification only after having passed by the technical committee / BOD detailed for aforesaid purpose.
 - 7. If the rates offered by the firm are approved, the stores must be supplied within 30 day from the date of receipt of order. The payment of stores will be made within 30 day.
 - 8. All firms which are not having granted registration with DGS&D/NSIC for the subject stores shall be required deposit bid security of Rs 4,000/- or 3% of the total cost of the indented supplies as per the rates quoted in the tender whichever is less. Bid security has to be remitted on Bank draft in favours of
